## **SELECTION PROCESS AND TIMELINE:**

### Application Submission and Review

Application packets must be received by the District before February 1st, 2023 at 5:00 P.M. Application packets may be mailed, emailed, faxed or dropped off in person, but must be received by the deadline established. Please call 541-549-0771 to confirm we have received your application by the deadline. Application packets will be evaluated and scored based on five criteria identified in the application packet. After evaluating and scoring the application packets, the District will invite the 25 candidates with the highest passing scores to participate in an assessment center.

### Assessment Center

An assessment center will be held at the Sisters-Camp Sherman Fire District headquarters station in Sisters, Oregon on February 15th, 2023. Applicants will participate in four separate assessment center exercises.

### Fire Chief Interview

The Fire Chief will conduct a Fire Chief interview with qualifying candidates on or about February 21st, 2023.

### Pre-employment Physical Exam

Candidates offered a position will be required to successfully complete a pre-employment physical exam, pass a physical abilities test and comprehensive background investigation.

### Start Date

The proposed start day for the position is March 1st, 2023.
